

**Carpenter & Smith® Spruce Up for Spring Sweepstakes  
(the "Sweepstakes")**

**Official Rules**

No Purchase or Obligation Necessary to Enter or Claim a Prize.

**Promotion Period:** The Sweepstakes begins at 12:00:01 AM Eastern Time ("ET") May 1, 2018, and ends at 11:59:59 PM ET May 31, 2018 ("Promotional Period"). All Entries must be submitted by 11:59:59 pm ET on May 31, 2018 as determined by Sponsor's computer.

**Eligibility:** Sweepstakes is open only to legal residents of the states in the Sponsor's customer footprint (NY), aged 18 years or older. Facebook fans who "Like" Carpenter & Smith will potentially receive our status updates on their news feed. No entry fee is required. Winners will be notified via email.

[Entrants are allowed one submission only; however, for each eligible individual who is invited by you and who fills out and submits an entry form in response to your invitation, you will receive one additional entry into the Sweepstakes.]
